#### How Free is Speech When Students Get Arrested For It?

In February 2010, the Israeli ambassador to the U.S. spoke at UCI. Palestinian students, enraged at his defense of Israeli actions, stood in turn while he was speaking and protested the speaker and the policies he defended. Each protestor was escorted out of the hall peacefully without resisting arrest. Ten students were arrested and convicted of crimes related to their disruptive speech. Where did the ambassador's speech rights end and the protesters' rights begin? Were the ambassador's free speech rights more valuable than the protestors' in this context? What right does the audience have to listen to the speaker or to listen to the protestors? Could you, should you go to jail for addressing a government official out of turn? Are there limits on the rights of peaceful protestors? The lead prosecutor and lead defense attorneys in this case will present both sides of the issue about what happens when speech rights collide.
