1. Page 10, line 26: remove “Robots and Roses” and replace with “Roses and Robots”
2. STIPULATION - Page 11, line 3: remove “The defendant’s” and replace with “Taylor’s”
3. STIPULATION - Page 11, line 14 (after stipulation 16): add “17. Taylor should be referred to by “Taylor,” “they,” or “their.”
4. Page 13, line 18: after “opinions,” add “relevant information from the witnesses’ statements,”
5. Page 32, line 29: after “that page” add “.” and delete “which was see”
6. Page 38, line 10: remove “Robots and Roses” and replace with “Roses and Robots”

16. Page 28, line 14: following “drowning.” Add, “I wrote my conclusions about Taylor Matsumoto’s death in a report that was made available to the defense.”
17. Page 28, lines 29-35: remove sentences starting with “The fixing of lividity...” up through the sentence ending in “...best guess.” and replace with “The fixing of lividity ranges between 8 to 12 hours postmortem.”
18. Page 28, line 38: after “June 8, 2019.” add new paragraph “I also noticed that Taylor’s body was somewhat stiff. Rigor mortis is the stiffening, or a hardening of the skeletal muscles. Rigor mortis generally sets in about three to four hours after death, peaks at 12 hours, and dissipates after 48 hours, or even longer when a body is in water. Given the fact that Taylor’s body was not completely stiff either at the time I examined Taylor or at 10:00 when I performed the autopsy, I did not think rigor mortis was helpful in determining the time of death.”
