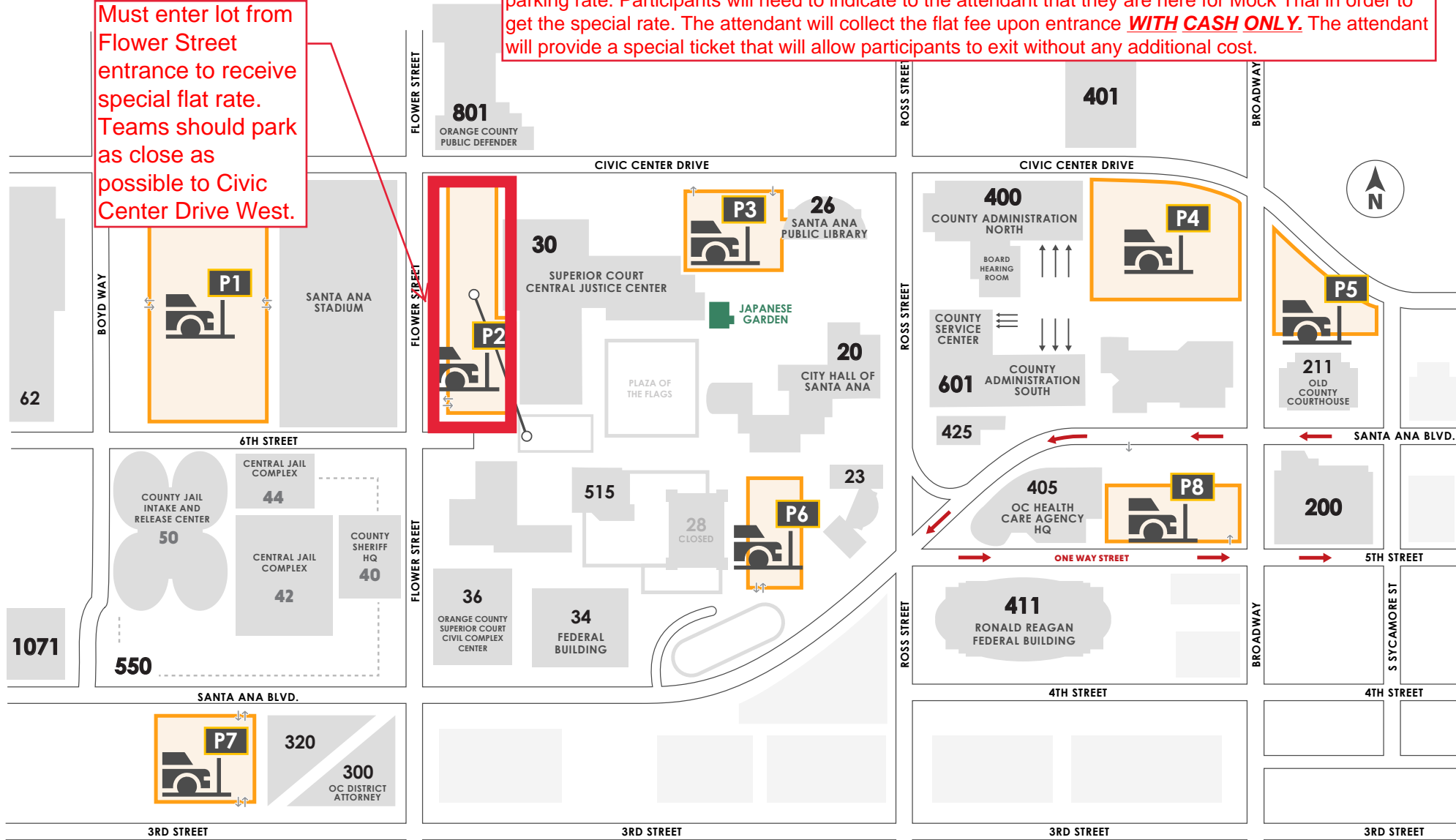

Super Block P2 will charge a flat rate of \$5 for Mock Trial participants (including spectators and volunteers). The special rate is only valid for this lot. If participants park at another lot they will need to pay the normal parking rate. Participants will need to indicate to the attendant that they are here for Mock Trial in order to get the special rate. The attendant will collect the flat fee upon entrance **WITH CASH ONLY**. The attendant will provide a special ticket that will allow participants to exit without any additional cost.

Must enter lot from Flower Street entrance to receive special flat rate. Teams should park as close as possible to Civic Center Drive West.
